### **TEACHING EXPERIENCE**

**Instructor:** 1999-Present

CMST 1061: Fundamentals of Communication

This course helps students gain practical experience in basic communication skills. Students learn how to communicate in groups, communicate cultural identities, communicate in everyday interactions, communicate in art, and communicate for social and political change.

CMST 1150: Introduction to Communication Studies

This course introduces students to the research methods, history, research findings, and communication contexts explored within the discipline.

CMST 2060: Public Speaking

This course introduces students to the theory and practice of informative, persuasive, and ceremonial speaking.

CMST 3107: Rhetoric of Contemporary Media

This course helps students examine our changing value systems as they are reflected in television shows from 1950 to present day. Students also become acquainted with the social, political, and economic environments surrounding these shows.

## **TEACHING PHILOSOPHY**

I believe that teaching and learning are not restricted to the classroom. I want my students to learn through doing. Reading and listening to lectures is certainly one way to learn, but I believe learning is more effective when students can put the concepts into practice. My wish is that, even after they leave my class, they will recognize how these concepts continue to play out in their personal and professional lives.

I believe that I can learn from my students as much as they can learn from me. Teaching and learning are flip sides of the same coin. There have been many instances in my classroom where I have walked out knowing more than I did when I walked in.

Finally, I believe that every student is an individual. It is a personal goal of mine to learn the name of each student in my class. I try to address them by name when answering their questions or when calling on them for a response. I want them to feel that they are an important part of the education process and not just a nameless face in the crowd. I get a rush of excitement at the start of each semester because I know I will be meeting a new group of students with whom to share the educational experience.
